### **CLAUSE 1**

- 1.3 The parties shall co-operate with each other and shall as promptly as is responsibly practical, relevant agreement.

### **CLAUSE 2**

### **SCOPE OF THE MoU**

- 2.1 Industrial Training & Visits: Industry and Institution interaction will provide an insight into the latest developments / requirements of the industries; the Second Party to permit the Faculty and Students of the First Party to visit its group Stores and also involve in Industrial Training Programs for the First Party.
- 2.2 Guest Lectures: Second Party to extend the necessary support to deliver guest lecturers to the students of the First Party on the technology trends and in house requirements.
- 2.3 Placement of trained students & Entrepreneurship: Second party will actively engage to help the delivery of the training and placement of the students of the first party on the technology trends and in fashion
- 2.4 There is no financial commitment on the part of the AIMAN College of Arts and Science for Women the first party to take up any program mention in MoU. If there is any financial consideration, it will be dealt separately.
- 2.5 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required.

### **CLAUSE 3: Validity**

**3.1 Renewal, Termination & Amendment**

This agreement shall remain in force from the date of last signature to a period of Five years, with the understanding that it may be terminated by either party, giving two months' notice to the other party in writing. The agreement may be extended by mutual consent of the two parties.

This agreement may be amended by an exchange of letters and/or sub-Memoranda of Understanding between the two institutions. Such amendments, once approved by both institutions, will become part of this document of the agreement.

**CLAUSE 4 RELATIONSHIP BETWEEN THE PARTIES**

4.1 It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership.
